HELLO COOL WORLD MEDIA SCREENING CONTRACT
Community Screening License for Free-Admission Events

By purchasing The Grizzlies Community Screening License, the Licensee agrees to the following terms:

This LICENSE is good for one free admission, non-broadcast, public exhibition screening of THE GRIZZLIES (the "FILM") to an audience. The cost includes the license fee for screening the FILM on either DVD or Blu-Ray.

_____ The Regular License Fee for screening the FILM is CAD \$1000.00, plus shipping & handling (return postage) and applicable tax.

_____ The Non-Profit License Fee for screening the FILM is CAD \$500.00, plus shipping & handling (return postage) and applicable tax.

In consideration of payment of the license fee provided for above, the LICENSOR has provided the LICENSEE with one (1) DVD or Blu-Ray copy of the FILM (plus 1 backup copy) to be used for the screening, access to the Community Screening Toolkit and this license to screen the film once.

In addition the LICENSOR hereby grants to the LICENSEE, without warranty, a limited, non-exclusive, non-transferable license to screen the FILM on the SCREENING DATE only, subject to the terms and conditions specified herein, as follows:

- The LICENSEE hereby expressly agrees that the FILM shall be used only for the permitted purposes as set forth in this AGREEMENT and for no other purpose.
- The LICENSEE agrees that the FILM may be exhibited once only, on the SCREENING DATE, but that permission for additional exhibition dates must be made to the LICENSOR by email or mail, at the addresses above, and will incur additional licensing fees.
- The LICENSEE agrees to show the FILM in a non-theatre venue, unless prior approval is granted by the LICENSOR.
- The LICENSEE will not charge admission for these community screenings. Donations may be accepted.

- The LICENSEE agrees that it shall not permit the FILM to be duplicated, sold, loaned, transferred, televised or made available online or to any other party not contained herein at any time or in any manner other than as provided for in this AGREEMENT.

With respect to the License granted hereunder, it is expressly understood and acknowledged by the LICENSEE that any rights, title, or interest that the LICENSOR maintains with respect to the FILM are expressly reserved by the LICENSOR.
