

THE GRIZZLIES Educational License Agreement

By purchasing The Grizzlies Educational License from Hello Cool World (**Licensor**), the **Licensee** enters into the following agreement (the 'Agreement') for one of the following Terms (defined below).

1. **Picture:** The feature film entitled "The Grizzlies" directed by Miranda de Pencier.
2. **Term:** The Licensor offers the following Terms, based on the product purchased:
 - a. **The Grizzlies Educational DVD:** includes an Educational and Non-Theatrical Public Performance Rights License for a single institution.
 - b. **The Grizzlies Educational Digital License (1 year option):** Educational and Non-Theatrical Public Performance Rights License for a single institution for one year from the date of purchase.
 - c. **The Grizzlies Educational Digital License (3 year option):** Educational and Non-Theatrical Public Performance Rights License for a single institution for three years from the date of purchase.
 - d. **The Grizzlies Educational Digital License (in perpetuity option):** Educational and Non-Theatrical Public Performance Rights License for a single institution in perpetuity from the date of purchase.
3. **Territory:** The Licensor has permission from Mongrel Media (Canadian Distributor who has granted non-exclusive sub-distribution rights to Hello Cool World) to offer Educational Licenses for The Picture in Canada only.

The Grizzlies Educational License, includes the following:

- Non-theatrical on-site Public Performance Rights (PPR) license, for a single institution. "Non-Theatrical Venues" include educational institutions; libraries; museums; governmental agencies; governmental institutions; community centres; and recreational facilities.

The terms and conditions of this license are as follows:

- The LICENSEE agrees that it shall not permit the FILM to be duplicated, sold, loaned*, transferred, televised or made available online** or to any other party not contained herein at any time or in any manner other than as provided for in this AGREEMENT.
- The LICENSOR agrees to replace any DVDs that arrive damaged or defective, provided the LICENSEE submits a request within 30 days from the date of purchase.
- The LICENSEE agrees that replacement DVDs will not be provided for discs damaged from regular use, or that were purchased more than 30 days before a replacement request is submitted.

**Libraries may include The Picture as part of their lending library/collection, provided lenders do not use the film for off-site public screenings.*
